Assaults- one at McGurks and another at 9<sup>th</sup> and Geyer – which was also among bar patrons. Rape: occurred outside our district but was reported from mom's house, within our district, which is why it is listed here. In the end it was deemed no rape occurred.

Sky cop has been located at Soulard market for over a week to help curb crime and larcenies down this past month.

Shot spotters are located around the city which hears gunshots and triangulates the location. Farmers Market vendors have reported aggressive behavior from homeless individuals on Saturday mornings before opening – Either TCF or the 3<sup>rd</sup> district will look into an extra patrol then to help.

## **Business Report**

Review of budget and year to date expenditures. Submitted preliminary tax rate of 53 cents to maximize our revenue for 2022.

#### **Old Business**

Camera update: Working on installation near 9<sup>th</sup> & Emmett. We are pursuing a couple other locations as well.

Need to do a Windows update on the laptops. We will be updating them ourselves and getting the licenses updated. Without the update the video feed from our camera system will not work.

#### **New Business**

The Peter and Paul homeless shelter in the neighborhood has a clean team that does street clean up around the neighborhood and other organizations can donate money to the program because it pays the homeless individuals from the shelter a \$12 hourly wage to clean the streets up. The SRG, CID, etc. donate but there is a portion of the SBD that is not covered (Kosciusko and the 7<sup>th</sup> St./Broadway corridor) in the current program. Commissioner Hoffman proposes we donate \$10,000.00 to increase the area covered so that our entire district, and the whole neighborhood will be included. This is good with our overall mission because another aspect of safety in the neighborhood, other than security patrols, is keeping the streets safe of dangerous debris including broken glass.

Motion to approve \$10,000.00 donation (subject to later review and approval of operating agreement to be circulated via email by Commissioner Hoffman) by Chairman Reynolds, seconded by Commissioner Tomber. Motion passes unanimously.

Traffic calming meeting last month was attended last month by Chairman Reynolds and Commissioner Hoffman. The meeting went over goals and what we want to focus on-particular corridors throughout the neighborhood. They will put together a proposal for us, the SRG and the CID to review. We hope to have a draft before the next meeting.

SRG safety committee is bringing back the safety walk and will be doing the first one on May 13<sup>th</sup>.

Commissioner Hoffman makes motion to adjourn, seconded by Chairman Reynolds.
