# TCF/Crime Report

No crime report or month recap from TCF. Chairman Reynolds and Commissioner Hoffman met with TCF representatives to discuss upcoming patrol schedules, which are being reconfigured to focus on overnight patrols.

Board discussed on going carjackings in the neighborhood and related arrests as well as the recent homicide on Shenandoah.

The Kia and Hyundai thefts are on the rise in the area, and we've handed out several of the remaining car clubs to neighbors.

#### **Business Report**

We are submitting a request for the second disbursement of tax revenue. Review of all revenue and expenditures. Our year-to-date expenses remain within budget.

TCF patrol car update: we put in a request with the highway patrol for a Ford Explorer and will be contacted when one comes available for us.

Discussion regarding general liability insurance policy. Commissioner Hoffman to obtain a quote and Commissioner Dougherty to look into the option or necessity of implementing a lease for our meetings at the Soulard Station.

### **Old Business**

Discussion regarding issues with the Circuit Attorney's office and their response to certain crimes in the neighborhood and arrests in which they refuse to seek a warrant or charges.

Traffic calming meeting will be August 10, 2022, at 1:30 pm in the Soulard Station. Purpose of the meeting is to go over the recommendations and feedback received from the public.

### **New Business**

We have someone applying to fill our vacant renter position on the board.

Discussed neighborhood street and trash cleanup discussion Commissioner had with Trinity Lutheran. The other neighborhood organizations are interested in contributing to the program as well. The SBD's contribution would be roughly \$15,000.00 and Commissioner Hoffman will prepare the budget and present for a vote next month.

Commissioner Rick brought up issues with ongoing crime, lack of response from the Circuit Attorney, and potential drone patrol program. Discussed other ways we can contribute to the safety of the neighborhood with our budget beyond additional police patrols.
